Introduction

Prestige Education Foundation

Padma Shri Awardee Dr. N. N. Jain, Founder Chairman, a topper from first batch of SGSITS, Indore recognized the importance of education and thus established Prestige Institute of Management and Research, Indore in 1994, the first private management institute in the state of Madhya Pradesh. The Institute was started with a vision of promoting quality education, research, and development not only in the state but also across the nation.

The Prestige Education Foundation (PEF) formerly known as Prestige Education Society (PES) has promoted various professional and technical institutions offering multi-disciplinary courses in management, arts, science, humanities, law, commerce and research at different levels, i.e. Degree, Post-Graduate Degree and Doctoral Level. As well as Engineering Institution offering Engineering and Technology courses, and to provide facilities for research development and consultancy in related areas. Prestige Institute of Management and Research, Indore (Proposed Deemed to be University)

Prestige Institute of Management and Research (PIMR), Indore was established in 1994 and was the first private B-School in central India. It is a well-established premier management institute of Madhya Pradesh. It is promoted by Prestige Education Foundation under the leadership of Padma Shri Awardee Dr. N. N. Jain who is also the founder chairman of Prestige Group of Industries. The Institute enjoys continuous fourth cycle of autonomous status conferred by University Grant Commission (UGC), India since 2006 and valid up to 2033. It is recognized by UGC under 2(f) and 12 (b). The Institute has also been accredited by National Assessment and Accreditation Council (NAAC), India and awarded NAAC A++ Grade with a CGPA of 3.57 in the year 2021 during Third Cycle, valid up to 2028. During the previous NAAC cycles, the institute was accredited with Grade A (CPGA 3.33) in the Second Cycle, and with Grade A (CGPA 3.11) in the First Cycle. The MBA program has been accredited by National Board of Accreditation under AICTE since 2003, recredited in 2012.

The Institute is recognised as Mentor Institution for NAAC aspiring institutions under the UGC Paramarsh Scheme by UGC and NAAC since 2019. It is also an ISO 9001:2015 certified Institute. PIMR is consistently ranked amongst the top B-schools in Central India by various leading rating agencies and amongst top 50 B-Schools in India. The Institute offers nine UG, eight PG and one Ph.D. programs. The institute is a recognized Research Centre and is affiliated to Devi Ahilya Vishwavidyalaya, Indore. Till date 143 research scholars have been conferred with a Ph.D. Degree and 81 research scholars are currently enrolled with the Institute's Research Centre.

The Institute has established Prestige Inspire Foundation ATAL Incubation Centre under Atal Innovation Mission, a scheme supported by NITI Aayog, Govt. of India to support start-ups and venture creation in Sept. 2018. Institutional Weaknesses

1. High value consultancy projects need to be undertaken.
2. Lack of Autonomy in admission of MBA students.
3. The institute does not have degree awarding status.
4. The institute is located in a Hindi speaking belt and many students comes from vernacular background.
5. Number of students comes from semi-urban/rural areas and lack competencies in soft skills.
6. Most students at graduation level do not opt for placement. Companies are unwilling to come to campus placement for small number of students at graduation level.
7. Difficult to start any course if the Ordinance of that course does not exist with the affiliating university.
8. Government regulations on fee structure do not allow institute to charge fee in MBA programme at par with other private self-finance Institutions of national repute.

2. Scope to further collaborate with legal departments, law firms, NGOs, and legal bodies.
3. Opportunity to undergo International Accreditation.

Institutional Challenges

1. Large number of private universities and off-campus deemed universities entering the state and specifically Indore.
2. State Government norms do not allowed institute to admit more than 5% of students from other state and therefore finds difficulty in national / global branding at MBA level.
3. Foreign institution are foreseen to enter the education domain with very large spending capabilities.
4. The institute is located in Tier II city and the industry is offering packages which do not meet the cost of living of Tier I city since the cost is higher in those cities.
5. Changing state government policies regarding semester system to annual system is detrimental to institute competitiveness.
6. Recruiting, attracting quality and experienced faculty is a major challenge due to varied external factors.

Prestige Inspire – Atal Incubation Centre by NITI Aayog

Prestige Institute of Management and Research, Indore initiated its visionary step to foster the growth of start-ups in the state of Madhya Pradesh. For this, in the year 2018, PIMR decided to establish an incubation centre aimed towards complete ecosystem support to the start-ups. PIMR applied for Atal Incubation Centre under Atal Innovation Mission, a scheme supported by NITI Aayog, Government of India to support start-ups and venture creation. Out of the total 2676 application filed 35 Atal Innovation Centre (AIC) from across India were shortlisted for further process. PIMR was selected in the first phase of the process in the month of May 2018. A period of 120 days was the phase one of the process to establish AIC operational. Many organizations are supporting incubates for start-up development and one of the recent organization HDFC Bank has allocated Rs. 35,00,000/- for the same.

It was setup with a 10,000 sq. ft. incubation space ready for use. AIC- Prestige Inspire Foundation (AIC-PIF) started its operation from September 17, 2018. The official launching and ceremony was held under the gracious presence of Hon'ble Smt. Anandiben Patel, Governor of M.P. and CG, Hon'ble Smt. Malini Laxman Singh Gaur, Hon'ble Mayor Indore, Hon'ble Dr. Satyapal Singh, MoS, MHRD, Govt. of India, Shri Sunil Ambekar, National Organising Secretary- ABVP, Shri V.D. Sharma, State General Secretary, BJP, Dame. Dr. Prof. Meher Master-Moos, President, Zoroastrian College.

The incubation centre was named “INSPIRE” with a motto for start-ups who wish to innovate to reach the zenith. “INNOVATE TO INSPIRE” is the core theme for AIC-PIF. It is the only government supported incubation centre in Indore. The incubator works towards experiential and Hands-on Learning, training, mentoring for innovation, research and entrepreneurship. Currently, AIC- PIF is currently supporting 60 start-ups to scale-up with operations and expansion, the list is as follows –

3. Ms. Shradhha Sharma (Founder, Yourstory) visited AIC-Prestige to interact with the incubates and motivated the founders by sharing her start-up journey.
4. AIC-Prestige in association with Atal Innovation Mission, NITI Aayog organized an ATL (Atal Tinkering Lab) Community meetup on November 7, 2022. ATL in-charges, School Principals, Mentors of Change from the region came together to discuss, ideate and interact with each other to help grow the Tinkering Movement in India.
5. AIC-Prestige partnered Central India Start-up Summit organised by Headstart Indore on September 17, 2022. With around 350+ start-ups, 70+ parallel mentoring sessions, 30+ start-ups pitching to VCs /investors with 15+ start-ups have been confirmed for follow-up meetings.
6. Mr. S H Abbas Mehdi (Additional Director from STPI, Ministry of Electronics and IT, GoI) visited AIC-Prestige on July 27, 2022. for an interacting session with start-ups to spread awareness about various initiatives taken by STPI to support start-ups and bussing entrepreneurs, with major focus on CHUNAUTI 4.0 - NGIS (Next Generation Incubation Scheme). The session was attended by more than 25 start-ups from the city.
7. With an intention to encourage start-ups working in the areas of technology, for the planned development and growth of Indore smart city. A demo day and seminar on ‘Smart Start-ups for Smart City’ was organized by the AIC-Prestige on June 10, 2022. Abhishek Bardia, Executive Head, MP Start-up Center, Government of Madhya Pradesh, Rishav Gupta IAS and CEO, Indore Smart City grace the occasion.
8. Hon’ble O.P. Saklecha Ji, (Minister of MSME and Science and Technology, Govt. Of MP) visited AIC-Prestige Inspire Foundation on May 26, 2022. He met various incubated start-ups and gave generous guidance and suggestions.

9. AIC-Prestige in association with Headstart Network Foundation and Microsoft for Start-ups organised a demo day for the start-ups from the SaaSStart pre-incubation program on February 26, 2022.
10. Hon'ble Mr. Suresh Prabhu, Former Union Minister and Current Member of Rajya Sabha visited AIC-Prestige Inspire Foundation on February 21, 2022.
11. Padma Bhushan Hon'ble Dr. V. K. Saraswat, Member NITI Aayog and Chancellor JNU, visited AIC-Prestige Inspire Foundation on December 12, 2021.

Social Initiatives as Institutional Best Practice

1. Title of the Practice : Social Initiatives

Institute is continuously focusing on implementation and dissemination of best practices especially in context to societal concerns with a concept of “VASUDHAIVA KUTUMBAKAM”. The Prestige Literacy Mission being transformed into one of the best practice focusing on education of the under privilege members of the society, in continuation with this a full credit course by the name of “SAMVEDNA” is being introduced in the curriculum for final year PG students recently. Beside this institute is inculcating values system amongst students, faculty and staff members with the concept of Indian Ethos, Yoga, and Meditation. In future Institute is also planning to promote Indian Culture and Patriotism of the youth, by the youth and for the youth.

2. Objectives of the Practice

- To provide basic education and knowledge to the under-privileged children.
- To develop social responsibility and awareness among the young generation.
- To nurture a humane mindset in the students through the right mix of sensitivity, awareness, compassion, and empathy as a crucial life-skill culminating towards a positive life attitude.

3. The Context

- During the “Literacy Mission” program it was found that the regularity of the under privileged children in the class is a big challenge. It is necessary to continuously be in touch with the children and their family to make them understand about the importance of education in their life.
- Convincing the parents of these children was challenging. They are more interested in sending their children for work to earn money. Parents do not agree easily if the child is a girl.
- Another challenge was ensuring the learning of each child during the session. As these children are from different age groups and different background, it is challenging and highly occupying to concentrate on each and every child for the volunteers.

It was a challenge to motivate students of the Institute in understanding that it is one of the necessary and important activities. The HR Club members under the guidance of Head of the Department and HR faculty members took initiatives to organise small events and programs such as EML sessions for the students in which senior corporate HR Executives addressed the gathering and informed them about the importance of social responsibilities. Then the associations with the NGO and other Social Welfare Clubs was completed, guiding the students to work in a direction. The advantage of NGO was that these organizations were working in slum areas on child literacy and had developed reading material and curriculum for the same. They however did not have classroom and teachers to teach the children. Transportation of children from different homes was also a problem.

4. The Practice

The “Literacy Mission” of PIMR has been launched in association with the NEEV foundation in 2014. PIMR’s “Literacy Mission” was started by conducting a survey in nearby slum areas with a team of faculty coordinator, student volunteers and few members of NEEV to identify the maximum children who do not go to schools or who have discontinued their studies due to some reasons. The survey helped us to know the reasons why the children were unable to study in the year 2014-15. On the occasion of Manthan (Institute Annual Fest) 2015, PIMR has donated Rs. 30000 to NEEV foundation for developing a new school infrastructure. The Literacy Mission started regular classes for these children in the year 2016-17. Children were taught using motivational movies, class room activities conducted by student volunteers. After few motivational classes, children were taught Hindi Varnmala and number counting (1-100). Children also learnt poem, basic manners and etiquettes. 13 children have been taught under the literacy mission. Prestige Education Society has donated a Van to support the mission. In Manthan-2016, these children have given their stage performance in the National Annual Management fest. This was done to help them develop confidence in themselves. In 2017-18, Literacy Mission conducted a drive where anyone can donate anything in cash or kind like stationery, bags, clothes, eatable items etc. Many students have contributed to the club by donating stationery, clothes etc. Another batch was started on August 4, 2017 where 29 children were identified and around 50 student volunteers are involved in the Mission. In September 2018, PIMR Literacy Mission started working in collaboration with ‘Sewa Bharti’ a renowned NGO. After organizing some activities at various centres

of Sewa Bharti, our student volunteers started conducting classes at different centers from January 25, 2019. Since April 16, 2019 PIMR Faculty members are also teaching children under “Literacy Mission” at the PIMR campus. During the pandemic period, a number of social initiatives were undertaken with the help of NGOs like Food Distribution, Stationery Distribution etc. After the pandemic period, the IQAC emphasized on the significance of inculcating a value system among students and in order to make it part and parcels of the institutional work culture, after a detailed discussion with all faculty members during Board of Studies a full credit course with the name “SAMVEDNA” was incorporated in the syllabus.

5. Evidence of Institutional Commitment and Success

Following activities were conducted under Social Initiatives, which define the success of the best practice :

- Prestige Education Foundation has donated a Van to support the literacy mission. It is a cost intensive activity as it requires consistent expenses for Van, Driver, Petrol and maintenance expenses.
- PIMR has donated Rs. 30,000/- to NEEV foundation for developing a new school infrastructure.
- In Manthan-2016, these children have performed on stage at Manthan (National Management Fest). They have given their introduction in front of all the PIMR faculties, students and also performed cultural activities.
- PIMR “Literacy Mission” have started working in collaboration with ‘Sewa Bharti’ a renowned NGO.
- On April 13, 2018, student volunteers have visited their place and conducted few activities and distributed stationery items and chocolates to them.
- On the occasion of Holi 2018, colours and pichkari were distributed among children and volunteers shared the story of Holi with these children.
- Organized a health camp at Niranjanpur Centre on October 7, 2018.
- Visited Jivan Umang Centre, Nai Basti and helped them to learn and improve their creativity through greeting card making, on October 28, 2018.
- Celebrated Diwali with the children of Bihari Basti centre on November 2, 2018.

- “Literacy Mission” has organized Wardrobe Purchase Day with Rs. 1/- on Children’s day with Rotract Club and Institute’s Marketing Club on November 14, 2018.
- February 19, 2019, PIMR volunteers have distributed stationery, donated by PIMR students, to the children of Chikitasak Nagar and Bapu Gandhi Nagar centres.
- After organizing some activities at various centres of Sewa Bharti, our student volunteers started taking classes in different centers from January 25, 2019. PIMR Faculty members are also teaching children under “Literacy Mission” from April 16, 2019 in PIMR campus
- Institute received a letter from Seva Bharti acknowledging and appreciating the contribution done by faculty and students volunteers.
- It was found that students who were taught, performed better in their school exams securing higher results.
- The students have learnt to empathize with the economically under privileged members of society and this can be seen by the enthusiastic way in which students voluntarily coming forward to donate clothes, stationery, funds, efforts and time to these students.
- Students of MBA programs undergo a vigorous Social Sector Internship for 90-120 hrs.
- Incorporated values of equity, inclusivity, and sustainability in all its activities by introducing students to live functioning of NGOs, Enterprises and Individuals, Government bodies working in Social sector domains and thereby developing an understanding of the social issues and creating superior societal value.
- A full credit course has been introduced as a part of curriculum for post graduate students named as “SAMVEDNA” where each and every student is required to spend requisite number of hours with social engagement activities with the help of NGOs within the state and beyond.

6. Problems Encountered and Resources Required

Basic problem encountered was the inertia of students where they are not motivated to such social welfare. Faculties and coordinators then gave few sessions and also few

sessions of various social workers were organized. Students then came forward to support in large group to take such initiatives. Resources required for this was a room and basic infrastructure like table, chairs, almirah and some fund was also required. Students collected a club fee so that can make a fund to run the activities. Then on the basis of requirements students collected fund from society and faculty members and also with other students who are not part of this mission.

The key to the practice is taking the support of an NGO which has prior experience of working in slum areas for child literacy. This is necessary for two reasons

- a. The parents will not send their children as trust is an important issue.
- b. The curriculum and pattern to be followed needs a lot of thought to ensure effectiveness and that the efforts translate to enhanced knowledge of children.

The sensitization of student volunteers as they need to be trained in dealing with children of all ages. The children from slum areas have not had a bath, hair is unkempt and they use abusive language and tend to get into physical and verbal fights. Volunteers initially experienced this as a major challenge.

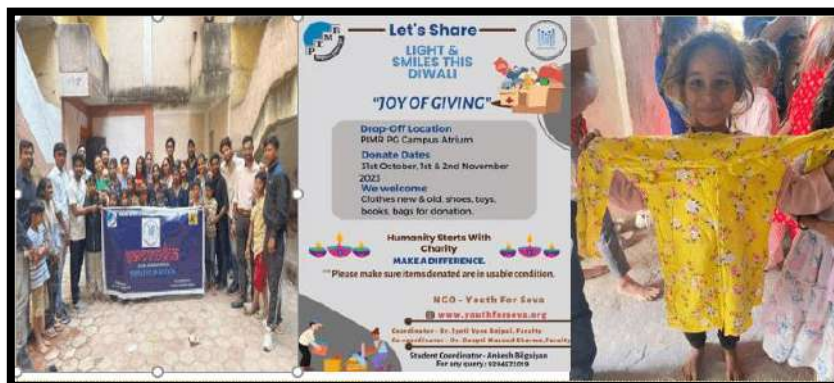

Detailed Strategic Vision Plan for Fifteen Years (With Five Year Rolling Implementation Plan)

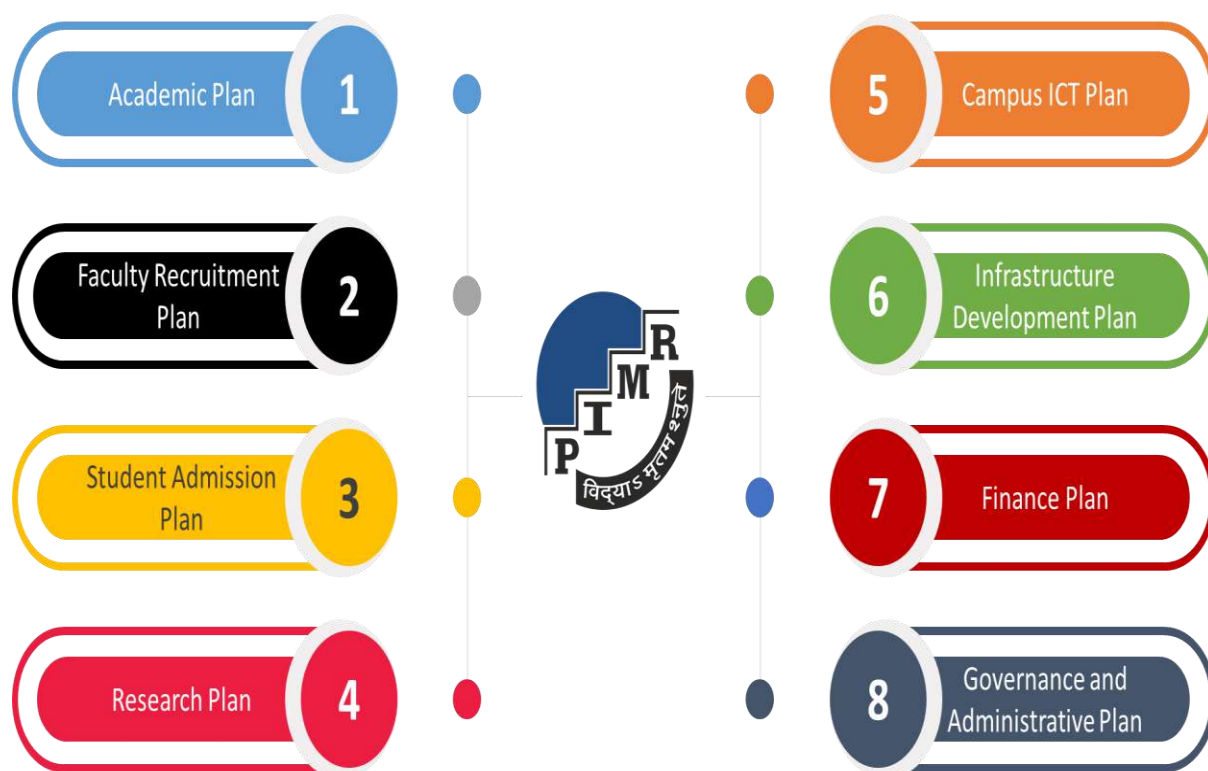

Faculty Recruitment Plan

The institute understands that the quality of faculty is pivotal for teaching and learning excellence. Institute has in place policies that promote and develop faculty efficiency. Beside this, the institute also provides the faculty members with a conducive work environment to maintain continuous association with the institute. The concept of flexi timings is a part of the retention practice. Faculty members are allowed a two-year lien in case they wish to go to Higher Education Institutions like IITs, IIMs and other top institutions etc. Faculty who leave the institute, go as the ambassadors of the institute. Faculty members are remunerated and awarded for various important activities like guiding students for major research projects, seminar presentation, summer internship projects, social projects to name a few.

To groom and enrich the faculty members, institute sponsors faculty to attend faculty development programs, workshops, conferences at National and International level. The institute regularly organises Case Writing Workshops, International Conferences, Research Methodology Workshop, Faculty Development Programs etc. Faculty members are encouraged to undergo certification programs and their fees is sponsored by the institute. Quality research publications in Scopus, Web of Science, UGC Care, and ABDC journals are encouraged with financial incentives as well as recognised in International Conference. The Best Faculty Award is awarded with a laptop as a token of appreciation, who have the highest score in 360 degree appraisal every year. In addition to this, faculty enrichment is facilitated by providing them with academic leave for Ph.D. and research work. The institute is a Ph.D. research centre and faculty members are motivated and supported to become Ph.D. Supervisors. Majority of the faculty members have a doctoral degree and also a large number of them are recognised Ph.D. Supervisors with Devi Ahilya Vishwavidyalaya.

The institute actively promotes faculty members to undertake Executive Development Programs, Management Development Programs and Consultancy projects and provides them with academic leave for the same. The consultancy revenue sharing ratio is 70:30 to be apportioned among the faculty and the institute. Faculty is also given a reduced load of both academic and / or administrative responsibilities in case of consultancy or long term training projects. Faculty members are given flexibility to invite senior corporates to provide inputs to the students in their respective areas which not only helps the students get a real life learning but facilitates faculties to cultivate a network.

Research Plan

- The Institution has in its vision and mission, ‘Innovation, Research and Consultancy’ as its focus area.
- Institute has a well-defined Research Promotion Policy which is available on the institutions website. The Institute has an established Research Committee to encourage research among Students and Faculty. Continuous support is provided to faculty members to apply for research projects offered by government / industry and other funding agencies.
- The institution is a research centre recognized by Devi Ahilya Vishwavidhyalaya, Indore. Since the year 2000, 144 research scholars have been awarded Ph.D. degree and currently 91 research scholars are registered with the research department.
- The institute focuses on research and publishes “Prestige International Journal of Management and Research” with an impact factor of 8.025 (SJIF) and enlisted in ProQuest, an International Online Database.
- The institute incentivizes / appreciate research published by faculty members in Scopus, Web of Science, UGC Care, and ABDC listed journals.
- The institute also appreciates innovation and has 28 registered Patents to its credit. It has established Atal Incubation Centre-Prestige Inspire Foundation established in September, 2018 and till date has mentored more than 60 incubate start-ups supported by 32 registered mentors.
- Research scholars undergo a rigorous coursework and their progress is monitored regularly through Research Committee. Scholars are required to publish minimum two papers in the area of their research before submission of the thesis.
- Institute regularly organizes international conferences, research methodology workshops, faculty development programmes for faculty and scholars every year as of now 19 international conferences, 16 national conferences etc. being organized by the institute in association with institute of national and international repute.
- During the last five-year faculty members have published more than 560 research articles in different journals and conference publications. In order to create a research culture among students and faculty, the institution has collaborations with many national and international organizations.

- More than 400 books and chapters in edited volumes / books were published and around same number of papers were presented in national / international conference – proceedings.
- Revenue of around Rs. 50 Lakhs was generated from training and consultancy during the last five years.
- More than 500 collaborative activities were carried out for research, faculty / student exchange and industry internships. 25 plus active collaborations and MOUs have been in action with industries, government and research organizations in India.

ICT Plan for Five Years

A.Y. 2024-2025

1. In the first year, the focus will be on developing a strong foundation for the university's ICT infrastructure. This includes upgrading the network infrastructure and installing high-speed internet connectivity.
2. Implement a comprehensive and robust Learning Management System (LMS) enabling students to access course materials, assignments, assessments and collaborative tools enabling hybrid learning. It will focus on the effective use of LMS, Simulation Software, Digital Marketing Tools, Cyber Security Measures, ERP software, etc.
3. Biometric tools like fingerprint scanners and facial recognition will be universally installed to effectively manage large pool of students. This will enhance security, streamline attendance, ultimately promoting a safer and more efficient learning environment for all the students.
4. Develop a mobile application that enable students to access course materials, schedules and other university resources from their mobile devices. This involves developing a mobile application that enables students to access course materials, schedules and other university resources from their mobile devices.

A.Y. 2025-2026

1. Enhance the existing cloud-based infrastructure that supports greater scalability and flexibility. It will allow the institute to store, access and manage its voluminous data and applications over the internet. This will facilitate greater scalability, flexibility and cost savings.
2. Adopt Multi-Channel Admissions Processes to ensure a strong and diverse applicant's pool. A comprehensive strategy will be implemented, encompassing both online and

3. Upgrading existing software to align with industry standards is a top priority for the university. Additionally, acquiring new software in areas like financial modelling, design and presentations, business intelligence, live response systems, AI and Data Analytics Software, etc., will provide students with enhanced exposure and prepare them to meet industry expectations, ultimately leading to better placement opportunities.

A.Y. 2026-2027

1. Expand the use of virtual labs and simulations to provide students with hands-on experience in management and science courses. This involves incorporating virtual labs and simulations modules into the curriculum to provide students with hands-on experience in management and science courses.
2. Expand the use of virtual collaboration tools, such as video conferencing and virtual whiteboards, to enable remote collaboration among students and faculty members across different locations.

A.Y. 2027-2028

1. Implementation of a chatbot or a virtual assistant that can answer student inquiries and provide 24/7 assistance. It will also guide students on assignments as well as assessments, and provide relevant information to them.
2. Develop an online assessment and grading system that provides students with real-time feedback and progress tracking. This involves developing an online platform for student assessment and grading, which would allow students to receive feedback and track their progress in real-time.

- 1.** Implement Digital signage and kiosks around campus that provide real-time information on events, schedules and university news. This involves installing digital displays and kiosks throughout the campus to provide faculty, staff, students, and visitors with real-time information on events, schedules and university news.
- 2.** Develop and launch an online course catalogue that enables students to browse and register for courses online.

Infrastructure Development Plan

The Institute has three campuses in the vicinity of 1 km. – Post-Graduate Campus, Under-Graduate Campus and Law Campus. In the last three years, augmentation in physical infrastructure, equipment, library and Digital Teaching-Learning facility has been done to ensure the need arose due to increase in intake, market demand for emerging areas of Technology and post Covid-19 pandemic challenges. As per the Vision of Institute, the Institute has created administrative block, academic infrastructure and amenities. Presently, construction of one additional Academic Block is also under progress to accommodate the need of increased intake of students in future. Currently institute is offering modernized academic, administrative and other amenities, details are as follows –

Academic and Research Facilities

- PIMR campuses have 66 classrooms, which are ergonomically designed, well furnished; ICT enabled, well ventilated and have access to natural light, and 10 tutorial rooms where practical classes are conducted.
- The Institute has more than 160 faculty cabins with individual laptops for each faculty and 3 faculty lounge with a combined seating capacity of 45.
- Atal Incubation Centre (AIC) is the heart of the Institute and it provides many special facilities like - Fruitation Zone, Flowering Zone, Sapling Zone, Smart Prototype Lab, Sky Lab, Seminar Hall, Industry 4.0 Lab, Recreation Hall for incubates and conduction of various events.
- The Institute has developed state-of-the art Moot Court in the Department of Law inspired from top national and international courts.
- There is an ultra-modern, advanced media studio available in the campus which also facilitates an in-house radio.
- The Institute has its own ERP Software ACCSoft version 2.0 since 2016 to facilitate E-learning, evaluation including conduction of test / quizzes (MCQ Base Types), attendance management, etc. Academic module of the software also supports teaching and learning features similar to MOODLE Software. The initial ACCSoft version was implemented in 2007 with intranet features for academic and administrative functions.
- PIMR offers spacious and modernized library resources, that provides 51,258 books, include literatures, course book and various domain specific books. There are 24,249 research collections, which include journals, monographs, doctoral thesis etc. PIMR

library also give facility of NLIST access to all the students and Air Online institutional version and Manupatra.com for Law. Institute also gives access to EBSCO business source elite, J-Gate Social Science and Humanities, Delnet, (The Case Centre formerly ECCH), Sage online journals access, INFLIBNET N-List Programmes to name a few.

Divyangjan Friendly Facilities

- The institute has developed Divyangjan friendly facilities for students that includes Reserved Parking, Ramp, Support Rails, Wheel Chair, Lift, Washroom etc.
- There is a dedicated section in the library for visually impaired students with braille equipments.
- The Institute has MOU with The National Association for the Blind, Indore to avail the facilities as well as the study material available in the Institute's Library.

IT Facilities

- There are seven Computer Labs and a Simulation Lab in the Institute.
- A total of 650 computers are available exclusively for student usage. Apart from these, computers and laptops have been provided to the faculty and staff for their use.
- The computing facilities include licensed softwares and also open source softwares, as per the curricula requirements. Some of the licensed softwares are Turnitin (Anti Plagiarism Software), SPSS, MS Office, SQL Server, MS Visio Professional to name a few.
- The Institute has high speed internet connectivity via leased line of around 500 MBPS from multiple vendors in order to maintain uninterrupted internet connectivity.
- The entire campus is Wi-Fi enabled with 24/7 internet facilities for the students and staff.
- The Institute has following servers available: Dell Poweredge R440, Intel Xeon-B (1.8 GHz), 32 GB DDR RAM 4 TB SAS HDD (ERP Server).

Administrative Facilities

- The administrative section in every campus has Director / Principal Office, Board Room/s, Accounts Section, Students' Section, Rotract Club, Boys' Common Room, Girls' Common Room, Stores, Student Counselling Cell, Healthcare Room, Sports Room, MDP Room, and Placement Cell.

- Being autonomous institutions, the institute has a Centralized Examination Cell that includes control room, printing press, strong room, moderation section and are under CCTV surveillance.

Sports, Yoga, and Meditation Facilities

- Prestige Institute of Management and Research is spread in 3 campuses. The institute has adequate infrastructure in terms of space and facilities for the physical wellbeing of the students, where students play games like Cricket and Football.
- The institute has outdoor Basketball court, four indoor Badminton courts and sports room for games like Table-Tennis, Chess and Carrom. In addition the institute also has a shared facility of sports ground with its Prestige Public School which is less than 250 meters away for games like Kho Kho, Cricket and Volleyball.
- To promote sports culture the institute has appointed sports officers and faculty coordinators, to oversee the development and participation of students in intra and inter sports tournaments.
- Every year the institute organizes “SPARDHA”, intra-institute and inter-institute sports competition, where games like Cricket, Football, Volleyball, Basketball, Chess, Table Tennis and Badminton competitions are organized.
- The students represent the institute at inter-institute, university level, inter-state, national and international level in sports like Kho Kho, Karate, Squash, Cricket, Weightlifting, Badminton, Football, Volleyball, Rifle Shooting, Chess, Table Tennis, Lawn Tennis to name a few.
- Institute also encourages better fitness amongst students, faculty and staff; and has established gym facility in the campus.
- Institute has special room/s which is being used for the purpose of yoga, meditation and music for students, faculty and staff members.

Other Amenities and Facilities

- There are Four Air Conditioned Auditoriums / Seminar Halls, which are fully furnished with the consolidated seating capacity of around 650 seats and latest multi-media facility. Guest lectures, placement processes, conferences, FDPs and workshops are conducted on regular basis. Video Conferencing facility can also be arranged in case of off-campus / off-shore expert sessions.

- Each building is facilitated with CCTV surveillance cameras to ensure security and safety.
- Institute has digital payment facilities for fees by students.
- The attendance for the staff and faculties is managed through the biometric (Face Recognition) system.
- Institute has a dedicated room for Literacy Mission (Institutional Best Practice) which is utilized to deliver education to the under privilege kids' from the society.
- There are two atriums which are utilized for student gathering and cultural activities.
- The law campus has a Legal Aid Cell.
- The Institute has five Guest House for visitors.
- Institute has facilities for Photocopy, Scanning, Colour Print Out, Spiral Binding and Stationery inside the campus.
- The institute has two well-furnished Cafeterias for students and has facilitated with LED TV. The canteen also has a dedicated Air Conditioned lounge for faculty and staff.
- There are separate hostels for Boys' and Girls' in the nearby vicinity of the institute which the students can avail.
- There are two buses and one multi-purpose van which caters to student and staff transit.
- All the campuses are equipped with heavy duty solar panels with a capacity of 30 KW output and meets more than 50% of the institute's electricity requirement.
- PIMR has set-up industrial grade Reverse Osmosis (RO) plant at all its campuses catering to drinking water facility.
- The institute has developed a Green house in the campus where the students can visit to experience the tranquillity and innocence of nature.

Governance and Administrative Plan

The governance of Institution is well planned and managed professionally and holds regular meetings of Board of Studies, Academic Council, Governing Body, IQAC and Finance Committee. Meetings are held to discuss the future plans of institute, infrastructural needs, curriculum, faculty requirements, welfare activities, social initiatives and other quality parameters. The activities of the institute are governed further by committees like publication committee, research committee, committee for curbing Sexual Harassment, Anti-Ragging Committee, Discipline Committee, Statistical and Analytical Cell, Examination Committee, ECCH Committee, MIS Committee, Admission Committee.

The various academic and extracurricular activities like Alumni, Summer Internships, Holistic and Music Centre, Student Counselling, Sports, Internal Examination, Film Festivals etc. of the institute are assigned to Faculty Coordinators. Event and activities are planned through extensive discussion in faculty meetings and executed through student committees. For academic governance regular meetings of HODs with faculty of respective subject areas are regularly conducted. To focus on individual program specific needs, institute has Program Coordinators who extensively coordinate with individual classes and mentors to guide students. For personal problems, these Coordinators if they are unable to help students due to nature of problem send them to the psychological counsellors of the institute.

The institute promotes culture of participative management. All decisions are taken by institution through various committees which find representation of faculty, staff, students, alumni, management etc. Besides the institute has various committees and the Director is financially empowered to take all financial decisions regarding budget decided in the finance committee meetings. Faculty coordinators are also given autonomy to draw funds for functioning of various activities as per budgets allocated after approval of the Director.

The institute has various clubs to promote specific subject areas with an objective to conduct workshops, seminars, short-term certification programs, and fund raising activities which are used for social causes. The Student Council is also in place which governs and execute all student cultural activities. The institute regularly participates in rankings processes to evaluate and assess its performance in-line with its vision and mission.

Administration of the Institution

The Institute believes in participative management for which Institute has empowered all the employees to manage various activities. In order to coordinate various events in the institute, faculties are appointed as event coordinator, which is rotated amongst the faculty. This system ensures that all activities have an environment where all the faculty, students and administrative

staff are demonstrating effective team efforts. The Institute has different committees like Library Upgradation Committee, Computer Upgradation Committee, and Placement Upgradation Committee which meet twice-a-year to suggest enhancements and infrastructural needs of library, computer, and placement cell respectively. The Institute has various coordinators for Programme / Committee / Cell for the efficient functioning which are as follows:

1. **Programme Coordinators:** Each programme and section has a separate faculty coordinator. The faculty programme coordinator looks after regular lecture, addressing any grievance of students relating to academic classes, faculty, etc. Also addressing personal problems of students either through counselling or referring to the institute psychological counsellor.
2. **Faculty Coordinators for Various Activity:** Each activity is coordinated by a faculty. For example Examination, Internal Assessment, Time-Table, Curriculum, International Conference, Pratibimb (Management Film Festival), Research Methodology Workshops, Faculty Development Programmes, Manthan (National Annual Student Fest) etc. These coordinators are empowered to handle financial and administrative execution of their events. They are supported by committees comprising of faculty, staff and students in most of the cases.
3. **Committees:** The institute has committees comprising of faculty, staff, and students for activities like Library Upgradation, Statistical and Analytical Cell, MIS, Discipline Management, Anti-ragging Committee, Internal Committee for Grievance Redressal, etc. These committees meet regularly and are authorised to recommend course of action to the Director on matters needed for better functioning of the Institute.
4. **Student Council:** The Student council comprises of President, Vice president, Secretary, Joint Secretary and members of council. The council is nominated every year for initiating, organising and executing all student related activities. The student council is supported and mentored by staff and faculty.
5. **Placement Cell:** The placement cell comprises of students who are nominated to become placement coordinators. The student placement coordinators manage the entire placement process, namely Company Identification, Liasoning, Follow-up, Placement process, and Student joining. They are guided by the Placement Officer, and Assistant Placement Officers of the department.

ITM-B first tracked our evolution as managers and leaders. Besides gathering distilled knowledge of management principles, techniques and skills, our perspectives and vision blossomed. And we learnt 'how to learn' about enterprises and environment, and how to look at any situation in a systemic and holistic manner with a long-time horizon. To me, that was the primary takeaway. This confluence of technology and management helped me shoulder decisive roles and responsibilities at ISRO from a manager to director to chairman, signing off with the Mangalore mission.

A specific gain from life at ITM-B were the lessons in institution-building. The new campus was in the conceptual stage. So, we also learnt about how to start an institution, seeing it happening there before us. Such lessons are not taught in books or classrooms. Let me elaborate: In 2000, I moved out of ISRO for a while to set up the Indian National Centre for Ocean Information Services (INCOIS) in Hyderabad. At INCOIS, we were starting from scratch—it was a new domain for me, with a new set of people and a new environment. I had just completed my PhD from IIT Kharagpur and went to the interview with a strategic plan. Within a couple of months, I could redefine the institution's vision and get the board to accept it. Originally planned as a data centre for the ocean, the institution was transformed into an information technology and knowledge enterprise. We shifted to a temporary location in Jubilee Hills while our new campus was being built. We wanted it to be a lean organisation with less than 100 people at any point of time. The IT boom was beginning and so I thought we must have a new culture in this new organisation. In two years, we became an internationally accepted institution and INCOIS became a key centre for the Indian Ocean region. In December 2004, the tsunami happened, and we rose up to become the tsunami-warning centre for India.

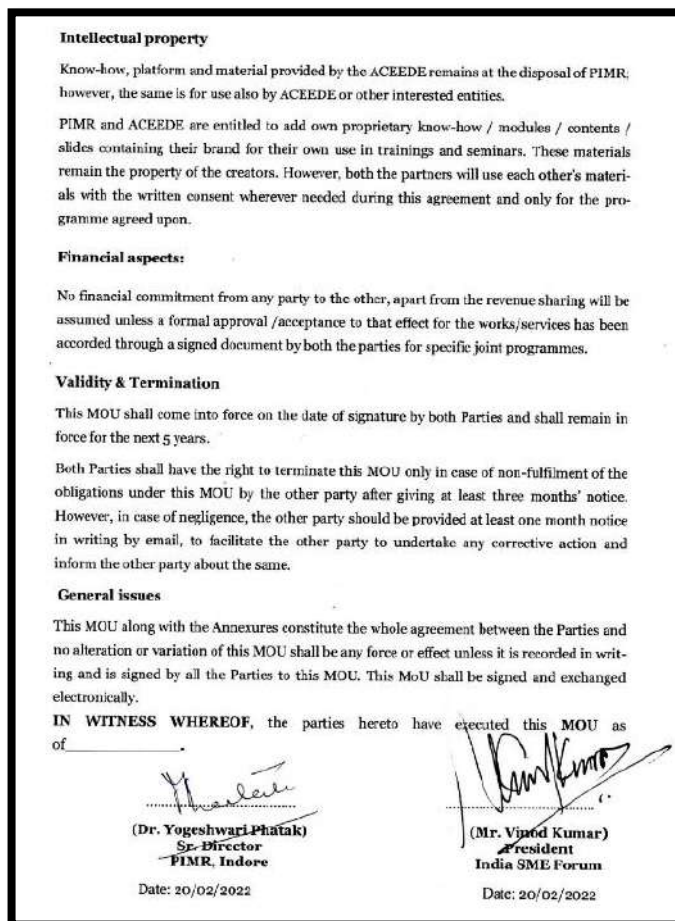
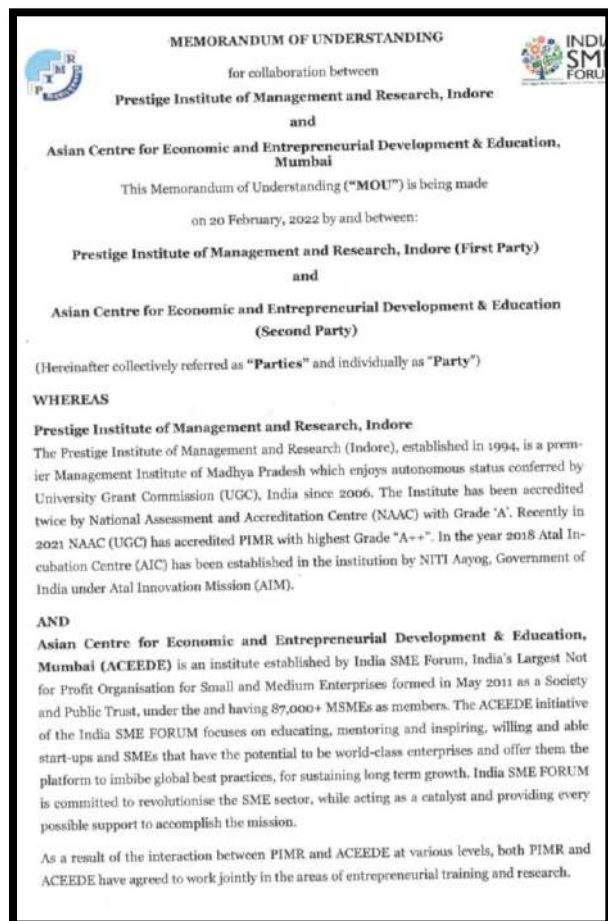
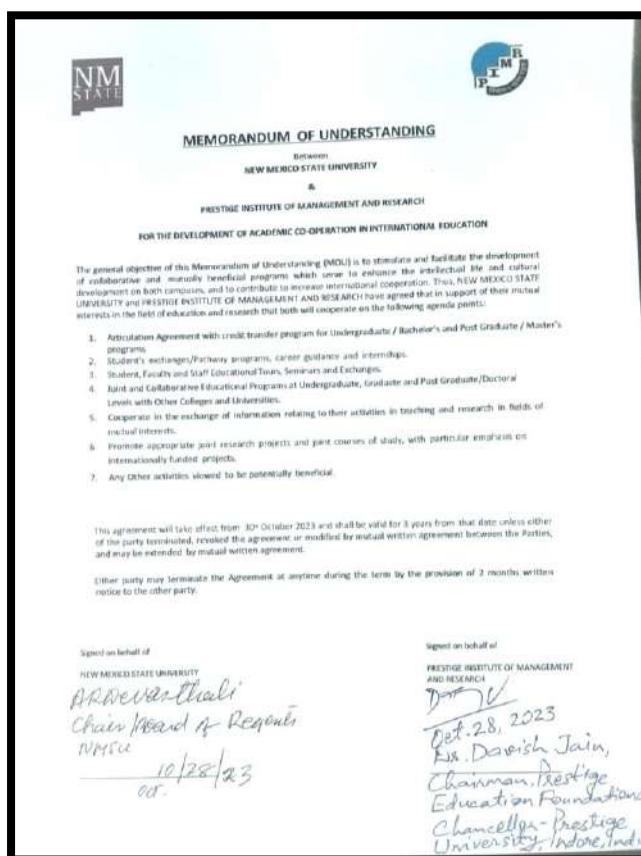

The resource person for the workshop was **Dr. Kusum Lata Agrawal, Professor** Dean- Research & IQAC, Coordinator at ABES Engineering College, UP, India.
